Query No. 1) Rationale behind providing option of additional shares to the shareholders of FIL.

Reply: BMF is a wholly owned (100%) subsidiary of FIL. FIL is a 88.17% subsidiary of the Transferee Company and BMF is thus a step down subsidiary of the Transferee Company, FIL is an operating company. No shares in the Transferee Company are to be issued to the shareholders of BMF since all shares of BMF are held by FIL which is a subsidiary of the Transferee Company and no company can issue shares to its subsidiary.

However, to protect the value of the investment of the Equity Shareholders of FIL, Scheme provides that shares of the Transferee Company in consideration of the amalgamation would be issued and allotted to the Equity Shareholders of FIL (other than the Transferee Company itself) instead of shareholders of BMF. The Transferee Company is a listed Company and FIL is an unlisted Company. As such the shares of FIL are not as liquid and marketable as the shares of the Transferee Company. It is thus considered desirable and expedient to provide an option to the Equity Shareholders of FIL to exchange their Equity Shares in FIL for Equity Shares of the Transferee Company, (refer Pt. 3(ii) & 3(vi) of the Scheme).
